徐振康律師目前為美國Birch, Stewart, Kolasch & Birch, LLP (BSKB)的合夥人,也是美國專利局註冊的專利律師(Patent Attorney)及加州註冊律師。徐律師畢業於台灣新竹清華大學電機系(B.S.E.E., 1993)及電機研究所(M.S.E.E., 1995)。在前往美國加州大學戴維斯分校(University of California, Davis)就讀法學院(J.D.)之前,曾經分別在台灣宏碁電腦(1997-1999)及台灣積體電路公司(1999-2001)擔任資深專利工程師。徐律師於2004年自法學院畢業後隨即加入BSKB至今。

徐律師自1997年開始進入智慧財產權的領域。徐律師的執業範圍著重在美國專利申請及專利(非)侵害/有(無)效性分析。徐律師在美國專利申請上有多年的經驗,也曾多次在美國專利訴願會出庭,並成功的說服訴願會委員推翻專利局的審定結果。徐律師所處理的專利申請案涵蓋數位訊號處理及其電路,半導體製程,電腦相關之軟硬體,平面顯示器及其驅動電路,無線通訊,數位多媒體等技術領域。徐律師也經常性地處理客戶所委託的專利(非)侵害/有(無)效性分析案件。

徐律師亦曾多次針對美國專利法的議題發表演說,其中包括AIA (America Invents Act), 美國法定專利標的, 美國專利申請及答辯策略, 美國專利說明書及權利要求項之撰寫,非顯而易知(non-obviousness)等議題。

徐律師所任職的BSKB事務所坐落於美國首府華盛頓特區附近,於1976年由兩家專利律師事務所合併成立,到今年已經有超過40年以上的歷史。BSKB約有60位左右的美國專利律師及專利代理人,其中有超過40%的美國專利律師及專利代理人曾經擔任過美國專利局的審查委員。BSKB為全球的客戶提供全面性的專利相關服務,包括專利申請,專利(非)侵害分析,專利有(無)效性分析,及專利訴訟等各項服務。BSKB每年的美國專利獲准量,在過去的十年中,始終在全美專利律師事務所中名列前茅(2021年BSKB所代理美國專利(Utility & Design)之獲准件數超過4,000件)。
